NORTH PARK HISTORICAL SOCIETY MAY 2011 MEETING NOTES

DATE: May 19, 2011 TIME: 6:30 PM

The first part of this meeting was a Business Meeting of the North Park Historical Society (NPHS) Board of Directors, and the second part was the activities discussion for the organization. These notes include updates as of June 7, 2011.

1. WELCOME AND INTRODUCTIONS

2. AGENDA REVIEW AND ANNOUNCEMENTS

The May Agenda was accepted as proposed.

Louise made a motion that we invite the developer of Wang's North Park, who is working on the old Penney's Building on University Avenue at Ray Street to come to a meeting and discuss their project, an upscale Chinese restaurant, with us. Hilda seconded the motion, and all approved. Update: Louise drafted the letter, which was emailed to Tom Eads of Wang's North Park on May 27. We haven't heard back yet, but Tom visited our booth at the North Park Festival of the Arts, and seems to have a high level of respect for the historical character of the building. See the May 17 issue of the San Diego Union-Tribune, Section C for an article about this building and others.

Bob Bauer talked about St. Luke's Episcopal Church on 30th Street, now under the control of the larger Episcopal Diocese, wanting to demolish their old chapel originally designed by Hebbard and Gill and two adjacent Craftsman cottages on 30th Street at Gunn Street. There will be a meeting on May 24th at St. Paul's Cathedral where the Diocese Board will discuss this proposal. All are welcome, and encouraged to attend. *Update: Bob, Steve, and Katherine attended this meeting, as well as a member of SOHO and a music group interested in using the chapel building. All speakers asked the Board to not approve the proposed Resolution to allow removal*

of the chapel and cottages by invoking "substantial hardship" if the buildings were designated historical resources. But the Diocese Board ignored us and voted unanimously to "forestall entanglements with preservation" and approve the resolution.

The photos of the old North Park Sign coming down in 1966 and the old Hoover High School being demolished in 1976 will break your heart.*
