## 5. CAR SHOW FOLLOW-UP

Thanks again to everyone who helped make our Third Annual Car Show a great success! We had a total income of approximately \$1,360 from the car show, including sign-ups, sponsors at \$100 each, book sales, and donations. Total expenses of approximately \$840 were related to port-a-potties, the City permit, the use charge for the Pep Boys historic photo on the poster, and copying flyers (next year we will do them in black and white). With the County grant funding included in offsetting expenses, we had about \$800 in profit. Steve noted that the Balboa Tennis Club was very happy with the event, and Babycakes had an excellent day with high demand for their food. The port-a-potties were not picked up until about 7 pm, but they were only taking up a few parking spaces and we feel they were safe from being vandalized because they were right by the clubhouse and tennis registration area. Mike Ward took some excellent photos, which many of the car exhibitors were pleased to receive via email from Katherine. # 6. WEBSITE UPDATE



# 7. MORLEY FIELD WALKING TOUR

The one-page (front and back) handout for the historical walking tour of the Morley Field area is complete. Thank you, Gabriela! We agreed on a date of **Saturday, October 20 at 9:30 am** for an experimental tour. Rhea, Valerie, Paul, George, Michael and Louise plan to come. Steve will lead the tour. More attendees are welcome. **We will meet in front of the Bud Kearns Swimming Pool Building** (and we will find out who Bud Kearns was).

# 8. BOOK PROJECT MEETING

Arcadia Publishing has asked if the North Park Historical Society is interested in submitting a proposal for an Images of America book about North Park. Arcadia produces the book at their expense and handles book distribution. The preparers/authors are responsible for obtaining and paying for photographs/rights (about 200 pictures), writing the text (primarily captions), and preparing the draft in Arcadia's template. The royalty of 8% of net sales that Arcadia gives preparers is about \$1 per book. They initially print 1,200 copies and may print more depending on sales. We would be able to order the finished book from them at a 40% discount to sell at retail ourselves. The retail cost is about \$22 for comparable community books in their series (e.g., Pacific Beach, which has sold about 3,000 copies). The New Book Group will meet on September 27 to consider if the Arcadia format and arrangement would be a good way for us to accomplish our goal of a second book that would fill in the gaps and carry North Park's story forward from our book, North Park: A San Diego Urban Village, 1896-1946 by Don Covington. The actual work of the book, if a proposal is accepted, needs to be completed within about 18 months at the most.



Update: Four members of the New Book Group met on September 27 to review the information from Arcadia, including the proposal that we need to provide to Arcadia. Katherine, Steve, Randy and Valerie favored preparing a proposal and the draft book if Arcadia accepts our proposal. George stated by email that he favors the idea and is willing to write about some topics. Via email, the Board agreed we have the dedication and energy to prepare a North Park Images of America Arcadia book. The first step is submitting the proposal, which must be prepared in a template provided by Arcadia. Katherine will take the lead and ask for input and assistance.

# 9. WATER TOWER PROJECT UPDATE

Historian Alex Bevil has submitted the application for the Water Tower and accompanying water system structures (some of which no longer exist) to be placed on the National Register of Historic Places as the "University Heights Water Storage and Pumping Station Historic District." The State Historic Preservation Officer (SHPO) has verified they have received the nomination. The City of San Diego will have 60 days to comment on the application. We will continue to track the progress of this important nomination.
