2. AGENDA REVIEW AND ANNOUNCEMENTS

4. TREASURER'S REPORT

The financials were sent to the Board in advance of the meeting. Between mid-March and mid-April 2013 we received income of approximately \$115 from sales of 8 North Park history books plus a \$20 donation. We renewed our website hosting for another 2 years for about \$162. We will ask Bill Vivian about renewing membership in the Car Club Council, as it did not seem we got any car show sign-ups as a result of outreach to that group. *Update: Bill did not feel it is worth it to renew.*

ACTIVITIES PORTION OF MEETING

5. BOOK PROJECT

The Book Group held its fourth working meeting on April 25, 2013. We reviewed on-screen the photos from St. Patrick's Church obtained by Jody, and Ed's photos from the descendants of the

first owners of his house that Valerie scanned. We especially liked the photo of Leslie Foote Barrows at her loom, and Ed showed us several beautiful placemats that she wove that the family gave him. George has obtained a disk with photos from the Plymouth Congregational Church and will share at the next book meeting. Ten pictures and captions and a chapter introduction are due early in June as a milestone submittal to Arcadia. We selected photos from Chapter 3 (1920-1945) for our initial submittal to Arcadia. Paul has written an excellent introduction to this chapter.

6. WALKING TOURS

We set the date for a Dryden Historic District tour on **April 27** and changed the date for the commercial area tour to **June 29**. *Update:* We appreciated members Judy and Bryan, and Board Member Bob accompanying George and Michael on a personalized walking tour of the Dryden District. Thanks also to Paul, Jody and Sharon for helping Steve and Katherine with setup and sign-in. It was a lovely day for a tour, and George received an excellent review for his presentation.

7. KLICKA SCHOLARSHIP

NPHS coordinates the \$2,000 scholarship awarded by the Klicka Foundation to a graduating high school senior who lives in North Park. Louise reported that three high-quality applicants have submitted, and she, Jody and Hilda will meet to select the winner soon. The Klicka family may want to present the certificate this year at the North Park Spring Festival of the Arts. If not, Louise will contact Christine Kehoe's office.

8. WATER TOWER PROJECT UPDATE

On April 25, the City Historical Resources Board (HRB) will consider supporting the nomination for the Water Tower and a surrounding district of other water system structures (some of which no longer exist) to be placed on the National Register of Historic Places. HRB staff recommended that the water tower be listed as an individual structure, but did not recommend that a district encompassing any other structures (or past structures) be designated. The State Historical Resources Commission will consider the application at their May 1st meeting, which will be held in Anaheim at the Downtown Anaheim Community Center, A Hall, 250 East Center Street.

Update: At their meeting on April 25, the City HRB unanimously voted to approve the Water Tower be designated as an individually significant structure, but they did not recommend a district be designated. The poster prepared by the McKinley Elementary School 5th grade class of Ms. Phillips was specifically cited as a wonderful "letter" of support. See the last page of these notes for a reduced version. One HRB member quoted Julia's request from the poster: "Please pretty please with a cherry gummy bear, chocolate chips and cinnamon on top!" Thank you, students, Ms. Phillips, and NPHS member Pat Taylor for supporting national recognition of our Water Tower!

At their meeting on May 1, the State Historical Resources Commission unanimously approved listing the Water Tower <u>and</u> the surrounding "district" of past and present water supply facilities as a significant California historical resource. The State also recommended that the water tower and district be listed on the National Register of Historic Places. Almost a dozen letters of support were written to the State, including the poster from McKinley Elementary School 5th Graders, which was much appreciated by the Commission. We should receive notice of the national decision in about 45 days. Thank you, everyone who wrote letters of support!

9. NORTH PARK FESTIVAL OF THE ARTS, MAY 18, FROM 11 AM TO 7 PM

NPHS will have a booth at the Festival of Arts in the non-profit group area at University Avenue and Grim Street. This event is our premier opportunity to reach out to large numbers of residents interested in the history of North Park. We typically sell a lot of books and talk about history with many people who are attracted to the posters Vince created. The event is on a Saturday this year and the hours are longer. We will set up at 9:30 am. George and Sharon will help Steve and Katherine set up the canopy and table. Ed will help at the booth from 11 am to 2 pm, Louise will come at 2 pm, and Bob will help from 5 pm to 7 pm. We want to have at least three people at the booth at all times, so please consider volunteering for a few hours, especially mid-day and later towards the evening. 
