The donations included a total of \$20 dropped into the water tower donation "jar" in exchange for a 1997 calendar with historic photos of North Park, University Heights, and Burlingame. We gave away five calendars for donations. Four members renewed for revenue of \$80 from dues. We sold one Arcadia book at the Festival of the Arts (net revenue of \$22.04 after tax) . We received 12 Car Show registrations for a total of \$120 and one Car Show sponsorship for \$100 (thank you, Randy!). Total income was \$382.04. There were no expenses in this time period.

- North Park Festival of the Arts: Saturday, May 12, 2018. Update: We were on University Avenue near Iowa Street from Festival opening to 5:00 pm. We sold one Arcadia book, handed out a lot of Car Show cards, and talked to many people, young and older, who were all very interested in North Park's unique history.
