# 5. WALKING TOURS

Morley Field Walking Tour On May 30, the Tuesday after Memorial Day, Steve led a walking tour of the Morley Field Recreational Area for 24 members of the Continuing Education program in the San Diego Community College District's "Rediscovering San Diego" class. Bob and Katherine helped show photos. In the Fall we may do a "North Park Now and Then" PowerPoint lecture for them.



On a related note, the Balboa Tennis Club in Morley Field celebrated 100 years on May 21 with fun events, including tennis exhibitions, food, music, tee shirts and history lectures. Their souvenir brochure summarized their history with a timeline and photos of famous coaches and players. Tennis Pro Geoff Griffin was one of the speakers about their history.

#### Balboa Tennis Club History - Born June 19, 1922

- 1922 Six courts erected by War Memorial Building in Balboa Park, close to the SD Zoo.
- San Diego Tennis Association receives lease to operate for the public
- 1925 Small clubhouse with locker rooms was built close to courts.
- 1933 Morley Field completed with eight tennis courts, a pool and other sport courts.
- 1939 Articles of Incorporation written recognizing BTC as a public, nonprofit corporation.
- 1940 Courts 9 & 10 were built.
- 1966 Courts 11-18, 19-24 built. Stadium 6 months later.
- 1967 BTC officially moved from SD Zoo parking lot to current location. BTC Clubhouse designed and built by famous architect Sim Bruce Richards.
- 1969 Hiroko and Bob Ray, currently Rays Tennis, took over as Pro Shop tenants at BTC. Bob Ray taught with Wilbur Folsom on courts 1 & 2.
- 1980 New tenant took over the Pro Shop. Tennis pros teaching at the Club included Robert Lansdorp, Ed Collins, Brian Turner, Jim Ferrari and Mark Tappen, amongst others. Various managers ran the club for several years including Judy Bushnell and Don Henson.
- 1983 The Club assumed all operational responsibilities. This is the time period when the Club started charging court fees and memberships were sold.
- 1988 Geoff Griffin was hired as Tennis Director and Pro Shop operator. Courts 1-6, 11 & 12 were rebuilt at this time due to the efforts of President Bill Stack.
- 1999 Club operating at a deficit. City was about to pull the charter. Club needed increase in revenue. Robin Rodger met with City and asked for another chance.
- 1999 2007 Robin Rodger served as President, Along with Treasurer Ron Celeste and CPA Joe Campbell, they turned the financial situation at BTC around in a positive way.
- 2005 Colleen Clery Ferrell hired as Club Director and is currently in her 18th year.
- 2007 2015 Dwight Van Slyke served as President. Video Security System installed and many other physical improvements.
- 2016-2021 Janene Christopher served as President and along with a solid base of board members, put BTC on a good fiscal and operational path. Janene helped implement incredible structural improvements at Balboa Tennis Club during this time period.
- 2022 Geoff Griffin retired as Tennis Director after 34 years. Hiromi Sasano hired as Tennis Director and operational owner of the Pro Shop.
- 2022-2023 Dr. Gary L. Smith is the current President. Membership boomed during COVID. The Club continues to thrive under his leadership.

















**Pauly's Addition Walking Tour** The team has developed the route, photo notebook and guide notes for the southern part of Pauly's Addition. We have tentatively set July 22, a Saturday, for George and Claudia to lead small groups starting at 10:30 am. The Board liked the idea of simply asking for donations instead of charging a set price for the tour. We will use our new personal amplifiers with clip microphones, as traffic noise is a bit of a problem, especially along Texas Street.

# 6. SLIDE AND PHOTO SCANNING PROJECT

We are in the process of scanning slides and notebooks with photos and notes from the Covington Family. At the end of these notes is a "cartoonized" map of the 1935-36 California Pacific International Exposition at Balboa Park, noted as "Copyrighted by Shell Oil Company." How many buildings and other features can you identify that are still there, perhaps with different names? Hint: The Ford Building in the lower right corner is now the San Diego Air & Space Museum.

## 7. SIGNS FOR DRYDEN DISTRICT

There are no street signs marking the North Park Dryden Historic District as there are for other districts like Burlingame. Since 2021, NPHS has been contacting various City staff about putting up demarcation signs for the Dryden District. We hope Council District 3 staff will come through for us.

## 8. COMMUNITY COORDINATION AND ACTIVITIES

In May 2023, we responded to requests for information (and received interesting information) and participated or arranged to participate in community activities as summarized below.


1. North Park Main Street's new Executive Director, Mark West, has offered NPHS a table at an occasional Farmer's Market to show our books and posters about North Park history. We originally proposed June 8, but we are going to postpone until August, as we don't have our branded canopy yet.

Also, NPHS attended the North Park Main Street Business Forum on May 11 at the Haven, located at 3381 30<sup>th</sup> Street. The event space is very bright and open and there were several presentations on resources for local businesses.




2. The Old Spanish Trail Centennial Celebration Association will be focusing their Centennial Convention at the Alpine Community Center on November 2 through 5, 2023. Information is available on their website at Old Spanish Trail Centennial Homepage George sent them some information about the location of the road in San Diego. He noted: "The western end of the Old Spanish Trail (OST) has two, time-related routes, both ending at a monument in Horton Plaza park in downtown San Diego. The initial route dates from 1923, located in the State Route (SR) 94/Imperial Avenue corridor. The eastern terminus of this route (and of SR 94 itself) is adjacent to Interstate Route 8 at Historic U.S. Route 80 in the community of Boulevard. East of Boulevard, the OST is located on Route 80 into Imperial County. Beginning in 1931, the second route is completely located in the Route 80 corridor within San Diego County." The OST Centennial Celebration Association was very appreciative of George's information.


3. Verbatim Books is coordinating a 2023 North Park Book Fair on Saturday, June 24, which will be an outdoor street festival including the North Park Mini Park, which has a built-in stage for poetry and author events. Katherine has requested a table where she can show NPHS books as well as her own North Park history book "History Snippets: PastMatters Stories of North Park".




- 4. At our May 18, 2023 meeting, the San Diego County Archives staff Aditi Worcester and Kiera Sullivan talked about archival records in the County's new state-of-the-art Archives facility in Santee. Some of the information they shared included:
  - They are the custodian of the historical record in the county, especially related to property ownership.
  - They have 170,000 recorded map sheets, dating from 1850 to present. The types of maps they have include assessment districts (1964 to present), subdivision maps (1869 to present), parcel maps (1966 to present), Record of Survey maps (1891 to present), State Highway maps (1935 to present), and miscellaneous others that don't fit those specific types (1915 to present).
  - If you want to conduct research at the Archives, they recommend phoning 619-219-6500 or emailing <u>archives@sdcounty.ca.gov</u> to make an appointment so staff can be ready to help. Or you can visit to just look through the index of key words on their computer kiosks, which also have digital images of their maps. However, their data and maps are not online remotely. You have to use their kiosks at the Archives.
  - Using the Grantee Index and Deed Books in their records, they showed us pages recording when Aaron Pauly filed his subdivision of Pauly's Addition on April 1, 1873 and the original map of the subdivision with street names identified as Briant, Landes, Skinner, and Pauly (now Alabama, Mississippi, Louisiana and Texas). Why those names? Because David Briant, David Landes, Lewis and Morgan Skinner, and Aaron Pauly were the landowners in the subdivision, as documented on page 179 in Deed Book 20.



After the meeting, Aditi emailed, "Thank you so much for hosting us yesterday! Kiera and I had a wonderful time meeting with the members of the North Park Historical Society – it was such an engaged group."









# 9. NEW CANOPY WITH LOGO, AND BALLCAPS

In investigating a new canopy personalized with the NPHS logo and name, we learned that local graphics firm A7D could help us with this purchase. We are coordinating with David at A7D, and hope to have a branded canopy this summer.

Steve and Katherine met with AKA, the printing company who made our tote bags, about possibly making branded ballcaps for NPHS. The Board approved coordinating with AKA for designs and cost estimates. Katherine and Steve met with Jason at AKA on May 15. He confirmed we can mix styles of "unstructured" all cloth (hat on left) and the "structured" style with mesh back (hat on right). AKA simplified our logo so it could work with an embroidered label and sent photos of possible designs. The Board liked the versions in the photos below. Steve and Katherine will pursue getting costs from Jason at AKA.





# 10. PLAQUE FOR WATER TOWER

Coordination with City Public Utilities Department staff regarding the feasibility of placing the plaque in a boulder or some kind of low wall next to the two-story building at the Water Tower site is pending return to some kind of normalcy.
